



Call for entries 2018-2019 **Specialist Training Course in Saddlery**

I. NUMBER OF PLACES

The following number of places has been announced for the year 2018-2019:

- Training Specialty: Saddlery. Two (2) places

II. COURSE LENGTH

- Specialty: Saddlery, option 3 years (2 places).
Essential qualification: Compulsory Secondary Education or equivalent.*

III. ENTRY REQUIREMENTS

Applicants must meet the following entry requirements:

- Have completed their Compulsory Secondary Education (e. g. ESO) or equivalent *.
- Be aged between 16 and 30 years old.
- Declaring that they do not suffer from any illness that may impede working with horses and teams.
- Have adequate knowledge of Spanish in order to get the maximum benefit from lessons.
- Pass the entry exam.

IV. ADMISSION TESTS

The exam will be one practical-theoretical test and an interview in the following order:

WEDNESDAY, 19 SEPTEMBER:

In order to access the course, the applicant must complete one theoretical-practical test.

- *Interview*
- *Theoretical-practical test:*
 - Knowledge of the tools and materials.
 - Knowledge of the different horse equipment made in a saddler workshop.
 - Hand-sewing practice.

This test will be judged by a teacher from the Real Escuela Foundation.

V. REGISTRATION AND EXAM FEES

The amount of sixty (60) Euros is required as application and exam fee. The applicants who apply for Saddlery will not be able to apply for any other speciality at the same time.

The applicant must tick in her/his application form the Specialty that she/he has selected and, in addition to the documents required, a bank transfer receipt of the sixty (60) Euros paid into the account specified below must also be provided with the application.

The transaction receipt must include the pupil's name and her/his Identity Number (identification of the sender), and the name of the Specialty applied for which the pupil makes the payment (Saddlery).



VI. REQUIRED DOCUMENTS FOR REGISTRATION

It is compulsory to submit the application form completed and the following documentation to apply for the entrance examination:

- 2 Photos (passport size).
- Photocopy of identity document or passport.
- Certified photocopy of the qualification required (approved by the Ministry of Education, Culture and Sports of the Spanish Government).
- Medical certificate.
- Proof(s) of payment of the admission fees.
- Authorization from parents or tutors in case of underage.

All the documents submitted by the applicants who have not obtained any place, will be returned to them at the end of the exams.

VII. APPLICATION SUBMISSION

The duly completed application and the documents required must be sent in any of the following ways:

VIII. GENERAL TERMS FOR ENTERING IN THE ADMISSION TESTS

Those pupils who wish to take the admission tests must first be properly registered; i.e.:

- The application form must be completed and submitted together with the other documentation required within the deadline provided.
- The registration and exam fees must be paid and the receipt for payment must be submitted.

The pupils for Saddlery must present the appropriate documentation on the day of the admission tests, or they will not be allowed to take their tests. The accreditation required:

- Identity card or Passport

All the Specialties' exams and tests will be held in Spanish language. Deadline for submission of documentation: 11 SEPTEMBER. No more applications related to this announcement will be accepted after the deadline for submission, except in the case that the documentation received has been sent by certified mail with a date before the deadline.

Entrance examination date for Saddlery Specialist Training Course: WEDNESDAY 19 SEPTEMBER

The list of admissible applicants to the entrance exams will be available on the website (www.realescuela.org) in the week of 11 September.

The list of the applicants admitted will be available in the week of 24 September. These applicants admitted must complete their enrolment on 8 October. The presentation meeting of the course will be on Monday 8 October.

Once the entrance exams are finished, and after all the results have been announced, the applicants may review their exams during a period of one week if they request it to the Training Office. This review will be in person in our facilities.

In addition to the applicants admitted, it also will be announced the applicants placed on the reserve list, i.e. those applicants who have passed the admission exams but have not obtained a place. The applicants on the reserve list could be admitted if any official applicant admitted would reject her/his place. The possible substitutions could be performed within 6 months once the courses have been started.



IX. FINANCIAL CONDITIONS 2018-2019

The entry fee for the SPECIALIST TRAINING COURSE IN SADDLERY is 800 € per year, so once the admission test is passed and the pupil has entered, this entry fee must be paid in a period of not more than three months.

The amount shall be debited from that participant's account.
