

SPECIALIST TRAINING COURSE **CALL FOR ENTRIES 2020-2021**

HORSEMANSHIP

This training provides the participants with the knowledge they need to achieve a broader education as a dressage rider, enabling them to develop their careers professionally. It is offered two options, depending on the academic education of the pupils, the first option is of two years and the second of four years. During this time the pupils will receive theoretical and, above all, practical lessons in a progressive manner and consistent with their learning process.

The training is structured in two courses, each of them of two school years. Although the overarching element is the practice of Dressage, the first course constitutes an approach to the basic aspects, and with the second course pupils obtain a specialization in educational, recreational and sports sectors.

During the training, the pupils will take part in many of the Royal School's activities, as gala and exhibition performances, events or reportages, and going outs to the competitions. They will also spend some practical hours in other disciplines in equestrian centres with which the School maintains collaboration agreements.

GENERAL TERMS AND ADMISSION REQUIREMENTS

For the course 2020-2021 are offered SIX vacancies. They will be assigned to the applicants who success all the requirements and get the best marks in the entrance exams.

TWO of the vacancies will be reserved for the applicants with ESO education, and it has a duration of two years.

FOUR of the vacancies will be for the applicants with Bachiller education or equivalent, and it has a duration of four years.

The requirements to apply for a vacancy are the following:

- Have completed ESO education (Compulsory Secondary Education), Bachiller (Baccalaureate) or equivalent.
- Be aged between 16 and 24 years old.
- Declaring that they do not suffer from any illness that may impede working with horses and teams.
- Have adequate knowledge of Spanish in order to get the maximum benefit from lessons.
- Pass the entrance exam.

ENTRANCE EXAM

The applicants must complete two exams: a theoretical part and a practical part, followed by a personal interview.

- **Theory exam:** This consists of thirty (30) questions dealing with topics referenced in the bibliography.
- **Practical exam:** It consists of executing a Classical Dressage test (attached to this document) on a 60 X 20 m. track.

REQUIRED DOCUMENTS FOR REGISTRATION

The scanned copies of the duly completed application and the documents required must be sent by email to formacion@realescuela.org. They will also be requested original on paper the day of the exams.

- The application duly completed.
- Certified photocopy of the qualification required.
- Medical certificate.
- Proof(s) of payment of the admission fees.
- Authorization from parents or tutors in case of underage.
- Photocopy of identity document or passport.
- 2 Photos (passport size).

Those applicants of foreign nationality must demonstrate their Spanish ability level to be able to get the maximum benefit from the course.

Those pupils registered in a Specialist Training Course at the School, will be not able to apply for any other course offered by the Institution.

ECONOMIC CONDITIONS

The entry fee for the Specialist Training Course in Horsemanship is 1,500 € per year, to be paid in instalments at the beginning of the course.

DATES OF SUBMISSION OF THE APPLICATIONS AND ENTRANCE EXAMINATIONS

The date of submission of applications to take part in the entrance examinations starts on Monday, 27th April until, at least, 15th September, 2020.

The dates for the entrance examinations will be published online after all restrictions related mobility due to the health alert have been lifted. (It will not take place before the 15th of September 2020).
