





# SPECIALIST TRAINING COURSE CALL FOR ENTRIES 2020-2021

#### **CARRIAGE DRIVING**

This training provides the participants with the knowledge they need to success in the carriage driving techniques, to be focused on both recreational and sports sectors.

The duration of the course is one year, and pupils will receive practical and theoretical lessons in a progressive form coherent to their learning process.

The specific technique of training is complemented by understanding concepts of hypology, history, conservation and equipment maintenance, horse care and management, and stables, which complete the concerning competences in this specialty.

#### **GENERAL TERMS AND ADMISSION REQUIREMENTS**

For the course 2020-2021 are offered FOUR vacancies. They will be assigned to the applicants who success all the requirements and get the best marks in the entrance exams.

The requirements to apply for a vacancy are the following:

- Have completed ESO education (Compulsory Secondary Education).
- Be aged between 16 and 28 years old.
- Declaring that they do not suffer from any illness that may impede working with horses and teams.
- Have adequate knowledge of Spanish in order to get the maximum benefit from lessons.
- Pass the entrance exam.

#### **ENTRANCE EXAM**

The applicants must complete two exams: a theoretical part and a practical part, followed by a personal interview.







- *Theory exam*: This consists of thirty (30) questions dealing with topics referenced in the bibliography.
- <u>Practical exam</u>: It consists of executing a Carriage Driving test on a 30 X 70 m. track.

#### **REGISTRATION AND EXAM FEES**

The amount of sixty (60) Euros is required as application and exam fee.

A person can apply for Carriage Driving, Horsemanship and Stable Hand Specialty at the same time per academic year, being the amount to be paid per Specialty 60 €.

#### REQUIRED DOCUMENTS FOR REGISTRATION

Those applicants of foreign nationality must demonstrate their Spanish ability level to be able to get the maximum benefit from the course.

Those pupils registered in a Specialist Training Course at the School, will be not able to apply for any other course offered by the Institution.

#### **ECONOMIC CONDITIONS**

The entry fee for the Specialist Training Course in Carriage Driving is 1,000 € per year, to be paid in instalments at the beginning of the course.

# DATES OF SUBMISSION OF THE APPLICATIONS AND ENTRANCE EXAMINATIONS

The date of submission of applications to take part in the entrance examinations starts on Monday 27<sup>th</sup> April until, at least, 15<sup>th</sup> September 2020.

The dates for the entrance examinations will be published online after all restrictions related mobility due to the health alert have been lifted. (It will not take place before the 15<sup>th</sup> of September 2020).
